


# **ABOUT US**


# FINANCIAL REPORT


### **OVERVIEW**

The TPA is financially sound and we will continue to work diligently to sustain the financial momentum needed in 2021.

The Colorado 600, our biggest fundraising event, had to be cancelled this year due to COVID-19 limitations. While many expenses were not refundable, some were able to be applied to hosting the 2021 event. The TPA would like to say THANK YOU to the riders who were registered to attend the 2020 C600 that donated a portion of their entry fee to the TPA, those donations helped tremendously with the non-refundable expenses.

To offset the loss of income on our cancelled C600 event, the TPA created a sweepstakes for a Special Edition TPA KTM 690. This effort started in the last guarter of 2020 will end April 2021. A large portion of our operating funds come from donations made by individual supporters as well as sponsors. We are grateful for the many donations over the past year that enabled the TPA to continue progress toward our mission.

# PIKES PEAK MULTI-USE PLAN

In October 2020 the TPA attended a regional webinar seeking input for an update of the Pikes Peak Massif Master Plan. The TPA was the only organization advocating for motorized use on Pikes Peak. The Pikes Peak Heritage Series is a program sponsored by the El Pomar Foundation in partnership with the Pikes Peak Outdoor Recreation Alliance and the Trails and Open Space Coalition. This virtual conversation was held to discuss the influence of the 1999 Pikes Peak Multi-Use Plan and the potential next steps in management and protection of the Pikes Peak region. The webinar featured an overview of the plan followed by a discussion among local recreation and conservation experts. We plan to continue our involvement as this process moves forward to help ensure all forms of motorized recreation, especially motorcycle use, are given fair and equitable consideration for recreational opportunities on Pikes Peak.

# BUREAU OF LAND MANAGEMENT RELATIONS

In 2018 the TPA helped organize a meeting between OHV user groups and the Bureau of Land Management (BLM) Royal Gorge Field Office in Colorado with the goal of better communication and common goals. These meetings over the last 2 years have been very successful, especially with our Salida based affiliated club, the Central Colorado Mountain Riders. The most notable outcome of these meetings has been the completion of 6 miles of new single track in the Four Mile Recreation Area.

### RE-IMAGINE WALDO CANYON

In partnership with Colorado Motorcycle Trail Riders Association (CMTRA) from Colorado Springs we participated in the Re-Imagine Waldo Canyon Community Vision in the Pikes Peak Ranger District. After an 18-month community-based process the citizen's plan was formulated including recommendations for the consideration of motorized trails. The TPA is thrilled because the USFS initially wanted to restrict/eliminate many forms of recreation that had previously been enjoyed in the area, including equestrian use. We convinced the USFS to listen to the community and fairly consider all ideas and suggestions for suitable forms of recreation in the area. Read the final report

# PLANNING TRAILS WITH WILDLIFE IN MIND

The TPA was selected to participate in the Planning Trails Advisory Group to represent motorized interests and recreational uses in the development of Colorado Parks & Wildlife (CPW) revised guide for Planning Trails with Wildlife Mind. Goals of this document include helping people, organizations, and groups to be proactive in considering wildlife when thinking about trails, trail planning, and management. The document will also include guidance for what wildlife issues should be considered for trails grant applications. Read the article

# OTHER PLANNING PARTNERSHIPS

The TPA and itsw affiliated clubs have adapted to the evolving recreational planning landscape in Colorado by participating in discussions such as Colorado Outdoor Partnership, NoCo PLACES 2050, the Colorado Outdoor Recreation Industry Office (OREC), Envision Chaffee County, Gunnison Public Land Initiative, and the Rocky Mountain Restoration Initiative (RMRI). We can see that these collaborations are important and that they will guide the development of the future public land planning and that it's important to be involved.

# LEGAL STUFF

The Trails Preservation Alliance continues to fight for OHV rights along with other motorized groups via legislation.

### **E-BIKES**

The TPA and Colorado Off-Highway Vehicle Coalition (COHVCO) prepared and submitted comments to both the BLM and USFS regarding proposed changes in the use of E-bikes on public lands. The TPA asked for consistency of rules across agencies (i.e. USFS, BLM, NPS, etc.), contending that E-bikes are bicycles (not motorcycles) and should appropriately coexist on bicycle infrastructure, that a single definition for E-bikes is necessary and needed and finally that there must not be any loss of motorized trails for exclusive use by E-bikes only. ### PIKE & SAN ISABEL NATIONAL FORESTS

In 2010 various environmental groups including The Quiet Use Coalition, Great Old Broads for Wilderness, The Wilderness Society, WildEarth Guardians, and Rocky Mountain Wild sued the Pike and San Isabel National Forests (PSINF) claiming the USFS had not done the necessary Environment Analysis on hundreds of miles of roads and trails within the six ranger districts encompassing the PSINF. In November 2020 the PSINF released their Draft Record of Decision and Final Environmental Impact Statement - the last step before the final decision is made. Overall the proposed Draft Record of Decision could have been much worse for motorcycles, but we are happy to report that through the TPA's diligent efforts, most of the motorcycle riding opportunities that exist today are likely to continue to be available for the foreseeable future in the PSINF. # CORE WILDERNESS PROPOSAL

The TPA successfully opposed the Colorado Outdoor Recreation and Economy Act (CORE) Wilderness Proposal in 2020. This piece of legislation would have closed many trails, put multiple-use trails at risk, and caused loss of significant expansion areas for future trail development. New efforts by Colorado's congressional representatives are likely to bring CORE back up in 2021.



# NATIONAL ENVIRONMENTAL POLICY ACT

The National Environmental Policy Act (NEPA) analysis required to create or maintain motorized access is one of the biggest challenges for the TPA. We continue to work with the USFS to make the Council on Environmental Quality (CEQ) regulations and NEPA process more effective, efficient, and equitable for the motorized community. # RIO GRANDE NATIONAL FOREST

The TPA Rio Grande National Forest objection was successful in ensuring that there was not a non-motorized corridor placed around the Continental Divide Trail - which is the entire western boundary of the Rio Grande National Forest. This is a critical win for motorized trail users as these routes are protected and preserved for motorized use by Federal law on a segment-bysegment basis in the Continental Divide Trail.

# RICO WEST DOLORES

Rico West Dolores litigation continues to work its way through the labyrinth of the Federal Court system. Every effort by the TPA Legal Team to accelerate a decision has been unsuccessful. The backlog of cases in the Federal Court system and the restrictions and limitations caused by the COVID pandemic have caused delays in processing almost every legal decision facing the Federal Courts. At publication of this TPA Year-End Report, there is no estimated date for resolution of the RWD lawsuit.

#### RGNF & GMUGNF

The independent revisions to the Forest Plans for both the Rio Grande National Forest (RGNF) and Grand Mesa Uncompangre and Gunnison National Forests (GMUGNF) are now complete. However, the travel planning processes for both forests have yet to be started; progress has been hampered by the extraordinary fire season challenging the USFS staff this year. Once the travel planning process begins, the TPA will be diligently engaged in the process.

# **GREAT AMERICAN OUTDOORS ACT**

The TPA worked with Senator Gardner for passage of the Great American Outdoors Act (GAOA). The GAOA provides funding for maintenance issues on federal public lands. The TPA has submitted recommendations for motorized projects under GAOA funding to the USFS and BLM, and we are optimistic that several of these projects will be funded and move forward in 2021. ### WILDFIRES

Colorado has experienced unprecedented impact from wildfires in 2020. The TPA worked with Colorado's Recreational Trails Committee to re-direct more than \$300k in unspent/returned OHV funds to wildfire response in order to preserve the many trails affected by the wildfires. We believe this effort will help avoid the long-term closures to trails and areas.

# **COLORADO AND BEYOND**

The TPA submitted comments on issues concerning the Continental Divide Trail (CDT) in the Carson, Gila and Santa Fe National Forests in New Mexico, Shoshone National Forest in Wyoming, and Grand Mesa Uncompangre and Gunnison NF, Colorado. In Utah, with the cooperation of our partner, Ride with Respect (RwR), we submitted extensive comments on the Ashley and Manti La-Sal National Forest plan proposals seeking to protect important motorized recreational opportunities. As Mr. Riggle says "we are all in the foxhole together!"



# **NEW MEXICO**

The TPA was able to assist our friends in New Mexico with funding to help open the Elephant Rock Motorcycle Trail Network in the Questa Ranger District, Carson National Forest in Northern New Mexico. The Trail network was developed in cooperation with the USFS to designate miles of old molybdenum mining roads into a system of motorcycle-only trails. In total, the entire trail system consists of some 35 miles of intermediate and challenging trails. More information can be found at ADV Pulse

# SALIDA/BUENA VISTA

TPA affiliated club Central Colorado Mountain Riders (CCMR) completed 6 miles of new single track in Chinaman's Gulch, part of the greater Four Mile Travel Management Area. The new trail, DudBobs, nearly doubles the motorized single track in the area and allows users to connect, via single track, from Bureau of Land Management (BLM) land to United States Forest Service (USFS) lands existing Triad Ridge trails. This trail was made possible with the volunteer efforts of CCMR, their partnership with the BLM, and funding from the Colorado Parks and Wildlife Off-Highway Vehicle (OHV) Grant program.vtAdditionally, CCMR and the BLM have been working diligently on a reroute of the Rainbow Trail to restore the connectivity that was lost as a result of flooding after the 2016 Hayden Pass Fire, and additional new single-track to BLM's Texas Creek area.

### **GRAND JUNCTION**

Two TPA affiliated clubs, Mountain Trail Riders Alliance (MTRA) and the Bookcliff Rattlers Motorcycle Club (BCRMC) members volunteered on multiple workdays with the BLM finishing the new 8-mile Windmill Trail in the Bangs Canyon area. This connects the Bangs Canyon trailhead to Windmill Road and the Gunnison River. In addition, MTRA and BCRMC split the \$4400 cost of a Cultural Survey for the BLM-proposed new 3.1 mile Cedar Point trail, also in the Bangs Canyon area. Completion of the survey this winter will enable the construction of the trail in Spring/Summer 2021. Once completed, Cedar Point will allow riders to make a complete loop from the Third Flats trailhead over Rollover Ridge to the Billings Canyon access road.

#### RICO/DOLORES

A special thanks to TPA affiliated club San Juan Trail Riders (SJTR) for their involvement in the The Chicken Creek Trail Project. This project involves two trails, Deer Lick and the Owens Basin connection. Both trails are of very high value for motorcyclists and improve the opportunities for motorized multi-use single track in the area by creating better looping opportunities and safer river crossing. # **SILVERTON**

The TPA, in partnership with the San Juan Trail Riders and leaders of the Colorado 500, led a 3-year effort to reopen the historic Minnie Trail. After years of work, meetings, and coordination with the BLM, the project has been approved to move forward. Trail work is planned to begin in 2021, as soon as the snow melts.
